Office Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of Sk. Md. Mamun, Chief Conservancy Officer, Rajshahi City Corporation to visit India after consulting a doctor and purchasing medicine for his wife's treatment from 29 September to 13 October 2023 or for 15 (Fifteen) days from the date of departure. This sanction is granted under the following terms and conditions:

- The Sanctioned leave must be availed within 35 (thirty-five) days;
 - He will draw his usual honorarium and allowances from Bangladesh in local currency;
 - All the expenses in connection with the visit shall be borne by Sk. Md. Mamun himself.
 - He will not be allowed to stay abroad beyond the approved period and will inform the government as soon as he returns to the country;
 - He will submit report within 15 (fifteen) days of his return to the country.
