- The expenses related to the travel in Austria & United States of America (USA) shall be borne by organizer 'United Nations Industrial Development Organization (UNIDO) & C40 CITIES' respectively. The expenses related to the travel in Canada will be borne by Mr. Md. Atiqul Islam himself;
- There will be no financial involvement of Bangladesh Government or Dhaka North City Corporation in this programme; and
- He will not be allowed to stay abroad beyond mentioned period.


