Now upon hearing, Mr. Shaikh Mohammad Zakir Hossain, Advocate For the petitioner Mr. Tushar Kanti Roy, DAG with Ms. Farhana Parveen Bithi, AAG and Mr. Kalipada Mridha, AAG and Mr. Mohammad Abul Hasan, AAG and Mr. Apurbo Kumar Biswas, AAG for the respondents and None appears for the Respondents and upon consideration of the said petition this Court doth order and do issue a Rule Nisi calling upon you the aforesaid respondents to show cause on or before the 04th day of December, 2022 as to why the inaction of the respondents to curtail Dherarpar Village from Ward No. 9 under the "03 No. Khoshash Uttor Union Parishad" and for adding the said Dherarpar village with Ward No. 2 of "04 NO. Khoshash Dkkhin Union Parishad, situated at Barura Upazila under Cumilla District for the greater interest of the peoples of the locality should not be declared to be without lawful authority and of no legal effect and why the respondents should not be directed to add Dherarpar village with ward no. 2 of 04 No. Khoshash Dakkin Union Parishad curtailing the same from ward No. 9 under 03 No. Khoshash Uttor Union Parishad both under Barura Upazila, District-Cumilla and/or pass such other or further order or orders as to this Court may seem fit and proper.

The learned Deputy Attorney General opposes the prayer for ad-interim order.

The petitioner is directed to put in requisites for service of notices upon the respondents by registered post as well as through usual process within 03 (three) working days.
