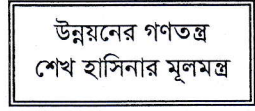

**Subject: Government's sanction for participating in the Training Programm on How to Manage and Provide Water Supply Service during 08-22 December 2019.**




