

**Subject: Government's Sanction for personal visit in India.**

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of Mr. Md.   - No speech harmful to the state can be made by participating in any meeting while staying abroad and
  - He will inform the Government as soon as he returns to the country.


