Whereas the petition above mentioned has been preferred by the petitioner above named to this court against, For a direction upon the respondents for not interfering with the toll collection at Brishalikka Amdani Raptani Kole Ghat by the petitioner pursuant to the license granted by Bera Paurashava on 18.05.2020 till expiry of its period **AND** Enforcement of fundamental rights guaranteed under Articles 40, 42 and 31 of the Constitution of Bangladesh.

Now upon hearing, Mr. Tapan Kumar Biswas, Advocate For the Petitioner and Mr. Kazi Mynul Hassan, DAG Mr. Md. Nasim Islam, A.A.G with Mr. Md. Nazrul Islam Khandaker, AAG for the Respondents and upon consideration of the said petition this Court doth order and do issue a Rule Nisi calling upon you the aforesaid respondents to show cause on or before the 25th day of April, 2022 as to why the respondents should not be directed for not interfering with the toll collection at Brishalikka Amdani Raptani Kole Ghat by the petitioner pursuant to the license granted by Bera Paurashava, on 18.05.2020 till expiry of its period and/or such other or further order or orders passed as to this court may seem fit and proper.

The petitioner is directed to put in requisites for service of notices upon the respondents in usual course and through registered post within 48 hours.
